#### 1. Call to Order

The meeting was called to order by Chairperson Atilano at 6:34 PM.

#### 2. Public Comment

Alex Gutierrez shared the meeting streaming live on Facebook.

#### 3. Announcements – Committee Members

#### 4. Consent Agenda

- a. 4/12/2022 Tower Construction Committee Meeting Minutes
- Continuation of Remote Attendance Accommodations (by Zoom) in Accordance with AB 361

Motion was made by Linda Crase, seconded by Kevin Northcraft, to approve the consent agenda as presented. Motion approved 5-0.

#### 5. Updates from Committee Liaisons

- a. Tulare Hospital Foundation CEO Smith commented he attended the Summer Jubilee hosted by the Foundation; it was a lovely event, and very well attended.
- Adventist Health Central Valley Network and Adventist Health Tulare Mike Shaffer, Kevin Northcraft: Mr. Northcraft noted the meetings would be quarterly.

### 6. Chief Executive Officer Update-Phil Smith

a. Tower Construction Committee Vacancy: Mr. Smith announced the committee is seeking candidates to fill one vacancy seat on the Tower Construction Committee, so please urge anyone interested that resides within Tulare to submit a letter of interest. It was further noted the appointment will be made by the County Board of Supervisors should the applicants submit their letter of interest.

#### 7. Discussion regarding the Tower Construction Committee Charter

a. Role of Committee Based on current District Goals: Chairman Atilano made suggestions to the charter (document provided prior to the meeting), noting there was additional language added expanding the charter to district-led projects vs. Tower only projects. Chairman Atilano asked for questions or concerns. Mr. Northcraft shared we have several projects going on; it may be good to present the

additional projects to the Tower Construction Committee. Mr. Northcraft advised the Tower Construction Committee has many levels of expertise. Linda Crase clarified that this would only be district-owned properties. Mr. Northcraft replied, yes. Linda reiterated the focus should be on the Tower. Ross Gentry advised, does other construction impact the Tower, and will the community view the Tower project as not being attended to?

Mike Shaffer joined the meeting at 6:54 PM.

John Atilano advised that we can bring up all projects and how they will affect the Tower. The Committee is recommending to the Board to adopt changes to the charter to include district-wide projects. Chairman Atilano suggested the attachment should be presented to the Board for approval. A motion was made by Mike Shaffer, seconded by Linda Shaffer, to approve the Tower Construction Committee Charter document with the recommended changes as noted on the document to the Board. Motion approved 5-0.
