1. Call to Order

President Kevin Northcraft called the meeting to order at 6:33 PM. All Directors were in attendance.

2. **Public Comment**

Paul Atlas spoke in opposition of Evolutions Plaza being a possible location for the VA's new facility, explaining it is ludicrous to take away the function of the gym from the facility and the community. Atlas also feels this would not be a viable project. Atlas added that he does support the AMVETS.

Jennifer Burcham inquired about timeframe of the proposal and the cost. She also added she is in support of the veterans but the request would affect small businesses and the community, and there would be a loss of jobs. Burcham stated she could not find information online to educate herself about Board discussion regarding VA lease proposal and stated there is no transparency by the Board.

Steve Harrell stated it is admirable to support the veterans but reducing the size of the facility would make it unusable. Harrell believes that, in its current state, the gym will turn itself around and be as productive as it was when it first opened. Harrell asked the Board to seriously consider all sides before making an agreement.

Jayne Presnell announced she is against the possibility of allowing the VA utilize gym space for their needs. She stated she is confused by the conversation and has been kept in the dark by management over the years, she noted that rumors are rampant, and any additional closures would be the death of memberships. She asked the Board if they want to be a property management or a healthcare and wellness business. Presnell said she didn't see transparency she expected from the Board.

Northcraft responded to the public that the Board has made no decisions and the majority wants to look thoroughly at options. If the Board proceeds, there will be public input before any decisions are made.

3. Announcements – Board

CEO Ormonde introduced Robert Pardo and Steven Cody from Catalyst Capital. Mr. Pardo stated that Catalyst Capital is working on identifying viable locations for the VA for a community based outpatient clinic to expand healthcare services.

Director Avila stated that the Board is divided on the topic of the VA but there is a need to hear all sides. He also stated that all discussions have been made in open session and there is full transparency.

Director Smith announced that this is a highly nuanced decision that was not taken lightly. Smith feels that property east of the Veteran's Memorial Building might better suit the VA's needs to expand services.

Director Gutierrez stated she is not against services for veterans, she is against locating their facility at Evolutions.

Vice President Jamaica concurred with other board members stating the District is a healthcare district and we support Evolutions. At the time of initial discussions, the Board did not want to say no to the VA's request, they wanted to keep the VA's interest in Tulare. It was just a formality that was expressed.

President Northcraft stated we have wanted to keep the conversation going along with discussions with the City. We thought it would be better to have services close and accessible and within our district. Northcraft stated the VA building is being moved and the District would like to keep in our county. Northcraft announced that he is opposed to utilizing Evolutions but believes we need to continue discussions with the VA. The Board facilitated to keep the conversations going but, at some point, a decision needs to be made.

Discussion was ensued by the Board. Director Smith inquired to Catalyst Capital about the potential in utilizing Catalyst's services to locate a facility. He stated there is a consensus amongst the Board and inquired if Catalyst would be willing to work with the Board in locating an alternative location. Mr. Cody stated they would be interested, however, the VA will not allow for a build-to-suit project. Secondly, Cody stated if there is no initial offer made by July 16, Catalyst will not be able to submit an offer, unless the VA extends the proposal due to not receiving any viable options. If there is another facility the District owns, Catalyst could take a look at the possibility. Director Smith stated the District will continue to work with the City on locating a facility. Director Avila

wanted to clarify that the District wants the VA clinic in Tulare, not specifically on a property owned by the District. He noted that it is the District's mission to bring healthcare to our District even if it would be located on another property.

Motion was made by Phil Smith and seconded by Mike Jamaica to not approve the Memorandum of Understanding with Catalyst Capital. Motion approved 5-0.
