
▶ **DISTRICT DEMOGRAPHICS**
2020 CENSUS DATA

- Validated redistricting data was released by the California Department of Finance on September 20.
- This data showed substantial changes in the area served by Tulare Local Healthcare District (“TLHD”) from 2010 to 2020, including:
 - Overall population growth of 9,168 (11.6%);
 - Changes in the demographic composition, most notably, increases in the proportional share of Hispanic/Latino population.





Follow man-made and natural geographic features, as much as possible



Drawn to comply with the Federal Voting Rights Act



Respect incumbency, if possible



Compact and contiguous, as much as possible



Other local considerations



Respect communities of interest, as much as possible
