#### **MINUTES**

#### 1. Call to Order

President Kevin Northcraft called the meeting to order at 6:35 PM.

#### 2. Public Comment

Over 26 public comments were received. Of those comments, six citizens wanted to listen to the Catalyst proposal, two had concerns with the terms of the Memorandum of Understanding, and eighteen spoke in favor of maintaining the gym at its current size and request that the Board not consider the proposal to lease space to the VA in Evolutions Plaza.

#### 3. Announcements – Board

Director Smith advised that he will be recusing himself from agenda item #5 (interviews).

Director Avila announced that the Board should have been more open and had better communication with the public. Avila stated that no one wants to take the facility away from the community. The Board needs to review its option and make more additions to the facility.

President Northcraft restated that he previously spoke in rejection of the VA proposal and respectfully disagrees with the proposal. Northcraft feels the gym is viable and stated that the gym is a health facility that serves our community.

# 4. Discussion and Action to Approve Memorandum of Understanding with Catalyst Capital Related to Request for Lease Proposals No. 36C26121R0097 for Department of Veterans Affairs (VA) Facility – Sandra Ormonde, CEO

A presentation was made by Catalyst Capital. Mr. Cody stated that this presentation is to review the MOU to move forward with a concept; it is their intention to keep the gym. Mr. Cody did state that the VA is only considering existing buildings in Tulare and Visalia. The deadline for lease proposals is December 14, 2021. If approved, the next steps would be to draw up a conceptual design and conceptual pricing.

Director Avila stated that, under the previous administration, maintenance was deferred for 16 years, and it is the Board's obligation to move forward and put together a preliminary concept. Avila further stated that positive cashflow would allow the District to put money back into the facility and it would be a risk to not consider a proposal. President Northcraft stated that the gym is a valuable asset, and a worst-case scenario would be that a new VA facility would be 5 miles away (Visalia). Director Smith stated he prefers the VA would choose a build to suit facility. Vice President Jamaica feels the gym does help veterans.

Motion was made by Kevin Northcraft and seconded by Phil Smith to reject the proposal presented by Catalyst Capital. Motion approved 3-1 with Xavier Avila voting no.

# 5. District 3 Director Appointment

(Prior to discussion to appoint a new District 3 Director, Phil Smith left the meeting.)

- a. Discussion regarding interview process: Letters of interest were received up until noon on Monday, November 22, 2021.
- b. Review letters of interest and conduct interviews: Interviews were conducted by the Board with Cecilia Herrera and Maria Macedo.
- c. Discussion and Action Related to Appointment of District 3 Director: After consideration of all interviews conducted, a motion was made by Xavier Avila and seconded by Mike Jamaica to appoint Margaret Fidler as District 3 Director. Motion approved 3-0.

# Discussion and Action Related to American Rescue Plan Act Funds Request – Sandra Ormonde, CEO

Ormonde advised that the City of Tulare had a study session in how to utilize ARPA funds. The next meeting of the City Council will be December 7 to discuss the allocation of ARPA funding. It was the direction of the Board of Directors to have the CEO work with the City to allow Police Department officers the same benefits at Evolutions as the City's Firefighters, work with the City to have Yoga in Zumwalt Park and can distribute the \$2 million request over a 5-year period.
